2. Property Manager Report- Tim Munch

- Maintenance

 - Burnt out High Pressure Sodium street lights are being replaced with the more efficient LED bulbs
 - Replaced iron work has been primed and painted
- Landscaping
 - Permits Committee met on Tue. October 14th-see Committee Reports below
 - Crescent City Cutters completed trimming of the property
 - Proposal for planting and pricing of replacement trees should be ready for November meeting
- Streets
 - EMSCO to start street repairs by the end of October. Owners directly impacted will be notified of dates and times of repair schedule
- Plumbing
 - Gresse Plumbing has completed sewer line clean out location and cover replacement throughout the property
- Pools
 - Since new gate code has been implemented we have had no problems
- Audits
 - 2013/14 audit will be ready for Board Review during the November meeting

3. Committee Reports

A. Permits - AI Lafaye

- Committee met on Tuesday, October 14th at the South Pool Gazebo at 6:08pm
- Unit 702, request to remove Crepe Myrtle between driveways of units 702 and 703;
 - Discussion centered around the limited space between these driveways and the potential of trees to UC1IIIagc them
 - Committee voted to approve the request at no cost to the owners however, no other trees shall be planted in this space; the area can be utilized as a garden or shrub could be planted upon request
- Unit 1904, request to install Solar Powered Lights on the Outside Rear Patio Fence Posts facing the common elements
 - Owner requested lighting for guest who arrive after dusk
 - Point was raised that this is not a designated walkway and people should not be walking in the area after dark
 - Existing lighting can be directed to illuminate the area if security is a concern
 - Committee voted to deny the request
